



If you only want us to position one arch, please nevertheless always indicate if you plan any treatment for the opposing arch - even if it is labial.

Terms and conditions of sale

Warranty

All products sold by TOP-Service für Lingualtechnik GmbH (TOP), whether manufactured by TOP or not, are warranted to be free of defects in material and workmanship for ninety (90) days from date of delivery. TOP's sole responsibility will be, at its option, to replace, repair or credit the purchase price of a product or component in the event of a defect. TOP's brackets, tubes, bonding trays and archwires are designed, manufactured and warranted for single use only. Misuse, abuse or failure to properly care for the products will void warranty claims.

TOP warrants only the fit of the customized brackets to the geometry of the dentition represented by the impressions made. The Incognito certificated doctor needs to approve the appropriateness of all components of the orthodontic appliance and of the appliance as a whole before installation. The doctor also has to take complete overall supervision of the treatment and medical wellbeing of the patient whilst installing the appliance and during the course of treatment. Except as expressly provided above, there are no warranties on TOP products, expressed or implied, including warranties with respect to description, quality, merchantability or fitness for a particular purpose. The purchaser assumes all risks and liability resulting from the use of TOP products, whether used separately or in combination with other products of TOP and other products.

The liability of TOP for any claim shall not exceed the purchase price of the products that are the basis of such a claim. In no event will TOP be liable for any incidental or consequential damages arising out of use or performance of TOP products. Nothing herein provided to the doctor shall be construed to imply or require that TOP will be responsible for, or incur any liability for, any treatment results or medical side effects of orthodontic treatment related to the use of TOP's products. This includes during the installation, in the course of, and at the end of, or after the treatment is finished.

Payment and shipping information

Payment for customized products shall be due on delivery. Prices, terms and conditions are subject to change without notice. TOP is continually striving to improve the quality and design of the products it manufactures. For this reason, TOP reserves the right to discontinue products, modify product specifications, and change pricing without notice. All prices are in Euro. It is important to take into account that the dates confirmed by TOP are dates of departure from Bad Essen, Germany, and not dates of arrival.

Return goods policy

Custom-made products or products produced on special order are not returnable. TOP's other products that are not defective in material or workmanship may be returned at customer's expense for full credit within 14 days of shipment. All returned goods must meet the following conditions: (I) Products must be unused, in the original, unopened package and in resaleable condition. (II) Products must be packaged so as to arrive at TOP undamaged. (III) Products must be shipped prepaid and insured for full invoice value. (IV) Products must be of current design. (V) A copy of the original invoice accompanies the products along with a note explaining the reason for the return.

Entire agreement
